Whatever your question or problem, there are people and organisations to assist you and provide support.

Remember:

- most of these services are free and confidential you can seek advice from them without your employer knowing;
- they will tell you your rights and the various ways you can pursue your rights. Then you decide if you wish to take the matter further and if so, how;
- let them know if you would like an interpreter to be involved when you talk to them sometimes this can be arranged;
- some of these organisations may not have call centres. You may need to leave a
 message or ring back when someone is available to talk to you. Don't be
 discouraged.
